Presentation Ceremonies

All prize ceremonies will take place on Sunday, 21 November 2021 for the DAIHATSU Indonesia Masters and Sunday 28 November for the Indonesia Open, immediately after the conclusion of each final. Medals/trophies/other will be presented to all champions and finalists.

In accordance with Player Commitment Regulations (BWF Statute 5.3.6), all players participating in the finals of a tournament must attend the final ceremonies directly after the match or must follow the instructions given by the organizers regarding ceremony protocol.

No equipment, including rackets and flags, are allowed to be brought onto the podium. Clothing worn during the ceremony must be in accordance with the BWF GCR.

Accreditation

Access to Tournament venues and other services is provided through personalized and photographic accreditation.

Accreditation will only be issued after a player/entourage/official:

- a) test negative for COVID-19 upon arrival
- b) submit to BWF/PBSI the pre-departure negative COVID-19 PCR test result – applicable to all participants either entering Indonesia and entering the bubble. The only accepted PCR tests are Nasopharyngeal Swab **OR** Naso-oro-pharyngeal Swab.

The number of complimentary accreditation passes available for Team Officials is dependent on the number of competing player from the same Member Association:

A limited number of additional accreditation passes for approved Team Officials will be available for purchase at a fee of USD\$150, charged to the respective Member Association, and payable at the tournament.

The fee to replace any lost or damaged accreditation passes will be USD\$100 on each occasion, charged to the respective Member Association.

The tournament reserves the right to refuse entry into any accredited venue or area or service (e.g. transportation) as a result of damaged or missing accreditation.

The fraudulent use of accreditation is strictly prohibited, and will result in access rights being removed, and penalties being applied.

Medical Services

A medical officer and physiotherapist service will be available during the DAIHATSU Indonesia Masters and Indonesia Open. This service is free of charge to players.

An appointment system will operate to ensure equal opportunities for all players, if needed.

A tournament doctor will be available during the tournament.

Anti-Doping

Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples.

Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE).

Badminton Integrity

Section 2.4 of the BWF Statutes (Code of Conduct in Relation to Betting, Wagering and Irregular Match Results) relates to anti-corruption and anti-match manipulation, and this code applies to all participants at this tournament.

To protect the integrity of BWF sanctioned tournaments, participants are not allowed to bet in any way on badminton matches, respect the principle of fair play, and shall not attempt to influence the course or result of a game or match.

Every person has an obligation to report to the BWF any approaches by anyone to gather inside information or to change the outcome of a matches.

All international flights to Bali have again been suspended. Please fly into Jakarta. All participants must arrive in Jakarta either on 9 Nov or 10 Nov. The PBSI will arrange, via chartered flight, for all participants to be transported from Jakarta to Bali.

Please send all flight details and visa requests to sekjen@pbsi.or.id as soon as possible in order for the host to arrange a chartered flight schedule from Jakarta to Bali. Depending on the number of participants and arrival schedule, it is possible that some participants may have to stay overnight at a hotel in Jakarta.

If the chartered flight is on the same day of your arrival, a waiting area will be designated at the airport before your departure to Bali. A one-way flight from Jakarta to Bali is approximately USD150 – 200 per participant, and is the responsibility of the participant.

PBSI will facilitate the processing of a Business E-Visa for all participants. The cost of this visa is USD100 per participant and is to be borne by the participant/Member Association. This fee is payable to PBSI and receipt will be issued.

PBSI/local organising committee officials will be at the airport to guide you through the arrival/transit/departure process.

ALL non-Indonesia citizens must have a special permission to enter Indonesia and as such, kindly complete the visa form and send to the email above.

NOTE: DO NOT APPLY ONLINE. PLEASE SEND ALL VISA REQUESTS VIA VISA FORM TO PBSI at sekjen@pbsi.or.id as the hosts have made special exemptions with the Government to issue letters to enter Indonesia. Once processed, PBSI will send these letters to all participants.

The tournament host and hosting Member Association will only communicate with a Member Association, and the hosting Member Association will only provide a visa support letter if the form is completed accurately and comprehensively, and supporting documentation is provided, where requested.

The tournament host and hosting Member Association accepts no responsibility for withdrawals made due to late or refused visa applications.

It is the responsibility of the Member Association to apply for the necessary visas in sufficient time, and all matters should be directed to the Embassy in charge.

Any visa support letter issued by the tournament host does not guarantee entry into Indonesia. The final decision is made by the Government of Indonesia.

COVID-19 Protocols

RESTRICTIONS & COVID PROTOCOL

ALL participants MUST arrive in Bali Jakarta latest 10 November 2021.

All participants must undergo a COVID-19 PCR test on arrival at the airport.

There is a five-day full quarantine for all international travellers arriving in Indonesia. However, PBSI and the organisers have arranged for an organized quarantine for all participants. The organizational quarantine starts from Nov 10 (Day 0) regardless of when you arrive in Indonesia.

No spectators are allowed for these tournaments.

It is mandatory for all participants including players on the reserve list that wish to be considered for promotion to submit the pre-arrival negative COVID-19 PCR test certificate to sekjen@pbsi.or.id and events.admin@bwfbadminton.org. **The only accepted COVID-19 PCR tests are Nasopharyngeal Swab OR Naso-oro-pharyngeal Swab.**

Reserves must also be in the organizational quarantine to be considered for any promotion to the main draw.

For participants from many countries, the pre-arrival RT-PCR test must be taken 72 hours before arrival to Indonesia. If there is a different requirement from the airline or your country of departure, please contact PBSI for clarification.

Athletes and entourage must remain in their room until the on-arrival test result is out. It could

take up to 24 hours to get the result back.

Once a negative test result is obtained, the participant can leave the room and move freely within the hotel compound or designated quarantine area.

Players will be allowed to practice on the practice courts from 12 November, subject to a negative test result for the on-arrival test.

All quarantine costs and internal transport from Jakarta to Bali (if required) is at participant's own cost.

1. Government of Indonesia entry and departure requirements:

- **ONLY Fully Vaccinated Players and Officials are allowed to enter Indonesia.** Individuals who may have medical reasons or other reasons which prevent them from getting a COVID-19 vaccine are advised to provide a letter from a public hospital in their respective country and submit to the hosts and the Government of Indonesia for consideration.

- Passengers entering or transiting through Indonesia must have a negative COVID-19 RT-PCR test taken at most 72 hours before arrival to Indonesia. The test must be in English. **If there is a different requirement from the airline or your country of departure, please contact PBSI for clarification.**
- Passengers must fill the Traveler's Health Declaration before arrival: (If required, provide relevant link here or attachment documents).
- **No foreign participant is allowed to leave the bubble or Indonesia before completing the full ~~eight~~ five (5) days of quarantine.**

3. Those who need PCR test to return to their respective countries can arrange it with the organization during the event.

4. Penalties:

BWF Status, Section 2.5.1 - Special Table of offences and Penalties Relating to breaches of COVID 19 Safety Protocols applies to this tournament.

5. General instructions:

Below are general COVID-19 safety protocols that applies to the tournament. The BWF will provide more details before the tournament that may include movement restrictions during the tournament.

Please be aware that the tournament takes place during the current pandemic situation with COVID-19. The conditions for hosting the tournament, as well as hygiene, sanitary and preventive measures will be those determined by the local authorities and BWF at all times.

All participants are required to follow the rules and guidelines of the BWF, LOC and local authorities as a condition for participating in the tournament. If the local authorities require it, each participant may have to deliver a responsible declaration before participating in the tournament.

Should the event be cancelled with short notice by the country's authorities, due to the Covid-19 situation, beyond the control of both Badminton World Federation and local organizers, neither of them will be liable for any costs related to travelling and/or accommodation made by players/officials for his event.
